1. Change of Status

SERVICES	Per movement (RM)
(a) From LCL to FCL or from FCL to LCL in addition to LCL/FCL rate there shall be extra movement charges in accordance with the number of extra movement involved Up to 20 ft length	45.00
(b) From LCL to FCL or from FCL to LCL in addition to LCL/FCL rate there shall be extra movement charges in accordance with the number of extra movement involved Over 20 ft length	70.00

The above charges shall not be imposed if the Commission is informed of the change of status at least 24 hours before the arrival of the vessel.

6. Surcharge For Urgent Stuffing/Unstuffing

Request for urgent unstuffing not in accordance with the CFS unstuffing schedule shall be subject to a surcharge, if the request is complied with. This surcharge is payable by the importer.	
(a) Up to 20 ft. length	130.00
(b) Over 20 ft. length	195.00
Cargo for stuffing should be sent to the Commission together with the relevant document 36 hours before the loading vessel is due to berth alongside.	
Request received after the above time limit will be subject to a surcharge. The surcharge is inclusive of all overtime charges. Acceptance of such request will depend on facilities being available. This surcharge is payable by the exporter.
